Yes.</i></p> <p><i>a) Without this exemption, co-operative start-ups would be financially prohibitive to get established in New Zealand due to compliance costs associated with preparing full Product Disclosure Statements.</i></p> <p><i>b) Given the impacts of Covid-19, this business model (where ownership and governance focus on the interest of members - enabling creating jobs, independence and long-term sustainable incomes) should be accelerated with barriers removed.</i></p> <p><i>c) Given the co-operative model / constitutions, these shares are more like a membership fee than an investment.</i></p> <p><i>d) The exemption enables co-operatives to provide the necessary information to members in a cost effective way while still maintaining investor protections.</i></p>	<p><i>Defer reviewing this exemption for 12 months to enable providing a thorough response to Q.4. 5, 6, across our membership.</i></p>
